Reading the rules is required by all CCES drivers, crew and car builders.

Sound: Thompson Speedway does have sound limits for race cars. For this event we will enforce the ChampCar BCCR 96dBa at 50 feet. You will get black flagged if you exceed 96 dBa and must make the car meet the sound level before you are allowed to re-enter the track. Put a muffler or two on your race car and you should not have any issues. Thompson has sound meters that will be used along side ChampCar meters.

Test & Tune Information: Test days for Champcar Endurance Series. You MUST be competing in the event following the Test Day in order to register. Any cancellations MUST be received by calling Taylor at the speedway office 860-923-2280 no later than 24 hours in advance to receive a refund.

Waiver and Wristbands: ALL drivers and crew must report to the ticket window at registration to sign the waiver and receive a waiver wristband. You will not be allowed access to the track without this wristband. Only the team captain needs to check in at registration to receive driver and crew credentials.

Garages: Garage spaces are 16' wide and approximately 30' deep. Garages may be booked online up to 2 days in advance. If it is within 2 days of an event, please call the TSMP office at 860-923-2280 in order to reserve a garage. If it is within 24 hours of the event all available stalls will be first come first serve on site the day of the event. Garages are \$50 per day.

Garage rental check-in is available at the Guest Registration building at the main entrance upon arrival. You will receive a sticker that must be displayed on your windshield for garage access.

Cancellations must be made at least 2 days before the event in order to receive a refund.

Paddock Electric: Some lighting is available but teams should bring additional lighting.

Pitlane/Paddock Electric: None. Bring generators.

Pit Passes: Teams are advised that all team members, family, and guests who desire Pit Lane access MUST purchase a Weekend Membership Pass through ChampCar at the track. ChampCar members can obtain a free pit pass by showing their membership card.

Guest Pass: Guests may purchase a weekend membership to ChampCar at the gate and watch the race for \$20.

Pets: Pets must remain on leashes and under the direct control of their owners at all times. No pets on pit-lane.

Children: Children must be under the supervision of a parent or guardian at all times. No small children on pit-lane.

Camping: Teams may use self-contained campers in their paddock spaces. Traditional camping spaces are available just inside the main gate. You must vacate the track on Saturday by 10:00pm.

Barbecues: BBQ's are allowed in the camping area only, provided all BBQ's are supervised at all times, a fire extinguisher is within 15' of the open flame, and all open flames are (at a minimum) 20' from all race cars, fuel storage or other flammable sources.

Restroom / Showers: Restrooms and showers are available in the paddock.

Gate: Open 24-Hours

Concessions: Will be open for this event.

Fuel on site: Sunoco Racing Fuels are available 24/7 at our Sunoco Fuel Station. We have the following fuels available: 93 Unleaded, 260 GTX (98 Unleaded), 110 Leaded, 112 Leaded

Weather: We're racing, regardless of the weather.

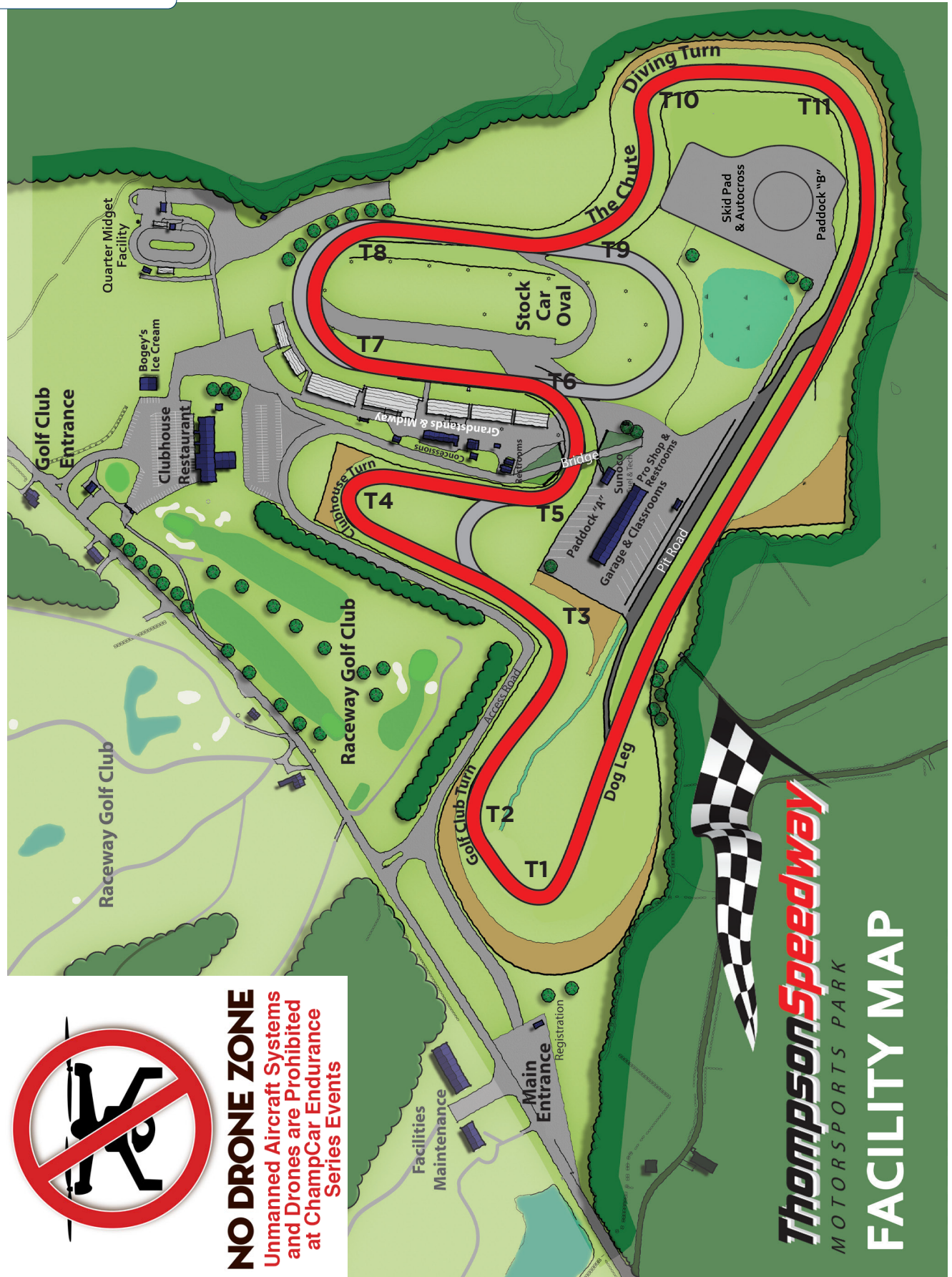

FACILITY MAP

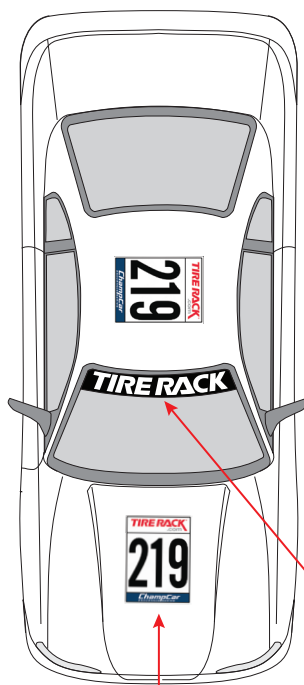

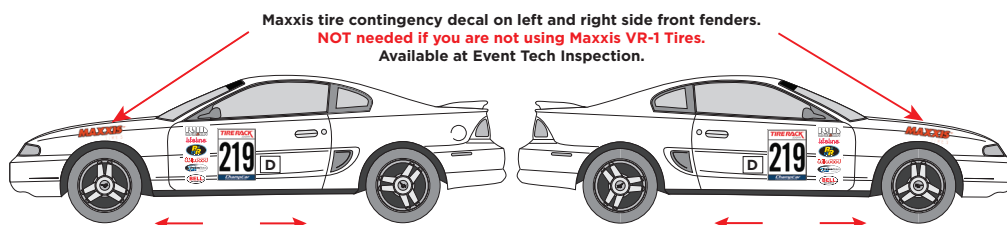
Convertibles and topless cars only. May face forward or toward drivers right like on the roof.

Only official ChampCar Decals will be allowed through tech. Do not print your own.

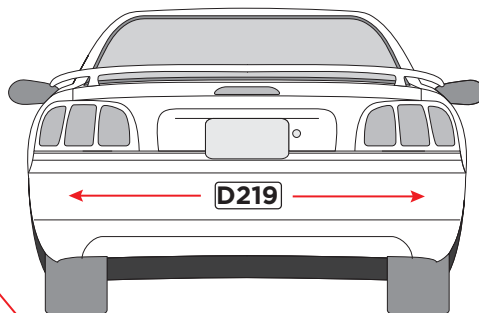
Official decal locations and order are required and are not a suggestion.

You will not be allowed to enter the track until decals are in the required locations.



Place sponsor and number panel as shown between arrows.

They MUST be displayed as in the image above. You may cut out the sponsor decals, but they must remain in the vertical alignment, and be in the same order. Failure to do so could keep your team from starting the race until they are fixed. 2020 requires that you add the Bell helmet decal below the Frozen Rotor decal. Bell decals will be available at tech.



Windshield banner is required at the top of the window. The background is optional. Per the BCCR, do not use white, orange, or yellow backgrounds. Cars without front windshields must have the decal at the top of the hood. The letters can be arranged to the curvature of the window. Team sponsor decals may go below the TireRack decal.

Additional event specific decals may be required at certain events. Instruction on placement of those decals will be available at the event and in the ChampCar Event Supplementals. Most likely place for the decals will be above the class letter on the doors.

If you have a custom wrap, please make arrangements for the required ChampCar decals in your design.

The number panel design will allow you to remove the top and lower Sponsor/ChampCar sections if you race with other sanctioning bodies. Just visit tech when you return to ChampCar to get new upper and lower sections of the number panel for free.

Waiver and Wristbands: In order to enter the facility, every driver and crew member must pre-print and sign each of the 4 (4) waiver pages.
One signature per driver/crew per waiver.

- ChampCar Communicable Disease Related Hold harmless, release, waiver of liability, and indemnity agreement
- ChampCar Release and waiver of liability, assumption of risk, and indemnity agreement
- Thompson Speedway Covid-19 Release and waiver of liability, assumption of risk, and indemnity agreement
- Thompson Speedway Release and Liability Waiver - No witness signature required. One signature per form please.

This will be your ticket to enter the event. You will not be allowed to enter the facility without this waiver. Go to <https://champcar.org/register/events.php> to print additional waivers.

No one – including any employee or event member – who has experienced any of the following symptoms at any time during the 14 days preceding event, or who is a household member, intimate partner, or caregiver of anyone who has experienced these symptoms, may enter the property:
