Please make sure you bring your car through Tech and Registration during the day. Tech will close at 6pm sharp.

Pit Lane: If you put tape or anything else on the pit lane guiderail, take it off before you leave.

Paddock: Paddock on the asphalt only, do not park vehicles on the grass or "no parking" zones. No vehicle testing, brake bedding, etc. on paddock roads or the skid pad area. Pit bikes, golf carts, side-by-sides must be operated by a licensed driver. Paddock speed limit is 15mph.

Garages: Garages can be rented from PIRC. Call 724-535-1000
No electrical cords can be run from a garage out to a trailer or RV.

Paddock Electric: See Electric Parking Map below.

Pitlane Electric: None. Bring generators.

Lighting: Very limited. The paddock gets really dark. Bring lights and generators.

Pit Passes: Teams are advised that all team members, family, and guests who desire Pit Lane access MUST purchase a Weekend Membership Pass through ChampCar at the track. ChampCar members can obtain a free pit pass by showing their membership card.

Guest Pass: Extra Temporary Crew Bands can be bought at registration with Laura for \$20. Everyone will sign in at the gate, get picture taken, and get a weekend gate band. After that team captains can go see Laura before the race starts to get a ChampCar temporary crew band.

Pets: No pets on pit lane. Pets are allowed into the paddock must be on a leash at all times. Please clean up after your pet. Pet access is a privilege not a right. The track reserves the right to deny pet access to the property at any time.

Children: No children under-18 allowed on pit road.

Camping: Yes, self contained camping is allowed. Do not nail tent or awning legs to the asphalt.

Camping / Camper Hookups: Premium RV spots, reserve through PIRC - Call 724-535-1000

Wood or other weight displacement materials must be used under all trailer or RV landing/leveling gear.

The pre-reserved electrical power spots are for those customers only. It has 50 amp service so have an adapter if your RV runs on 30 amp.

Barbecues: BBQ's are allowed in the camping area only, provided all BBQ's are supervised at all times, a fire extinguisher is within 15' of the open flame, and all open flames are (at a minimum) 20' from all race cars, fuel storage or other flammable sources. Paddock and camping areas only. Not allowed on pit road.

Restroom / Showers: Yes / Yes

Gate: 24-hours

Fuel on site: Pitt Race features quality Sunoco Race Fuels in the following blends: 93 octane unleaded, 100 octane unleaded, and 110 octane leaded. Credit card payment, limited to three charges per day.

Weather: We're racing, regardless of the weather.

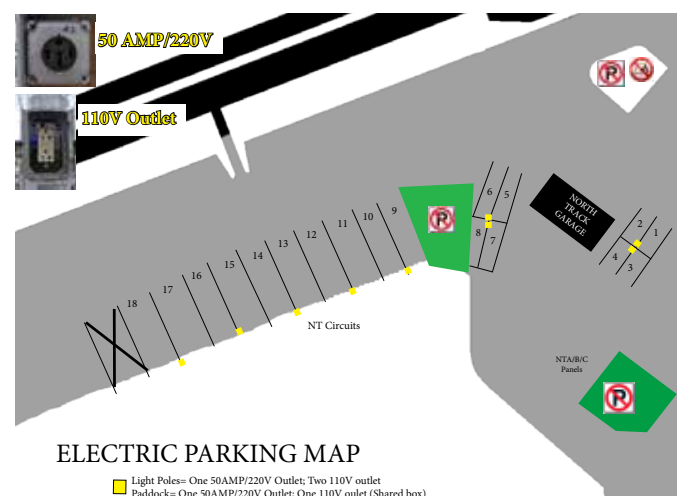

Quiet Time: Yes. 8:00pm - 8:00am. NO RACE ENGINES.

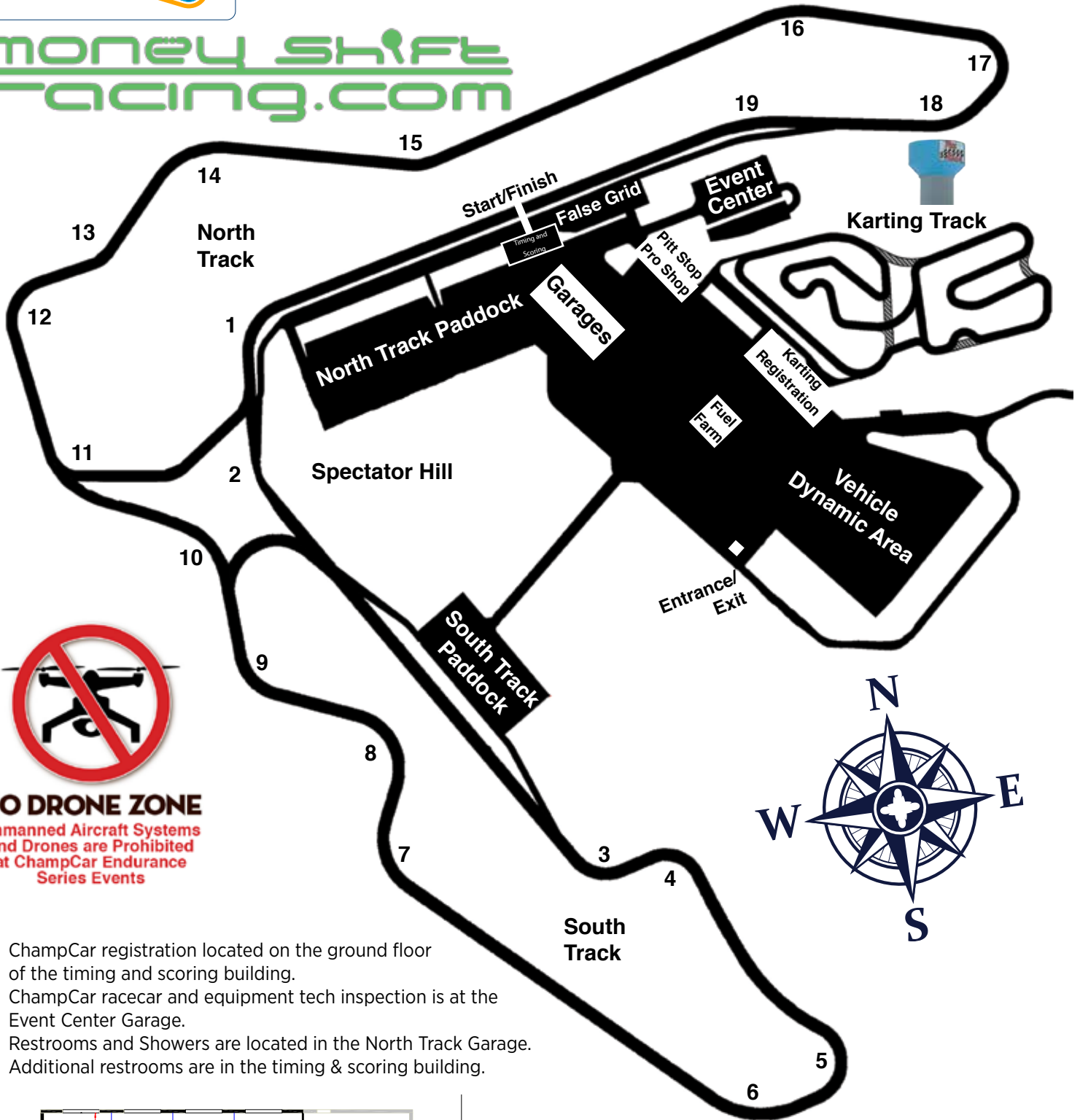

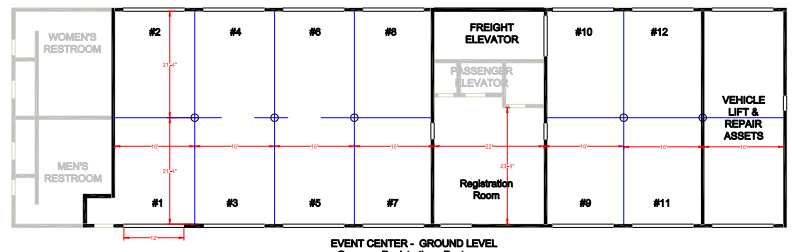
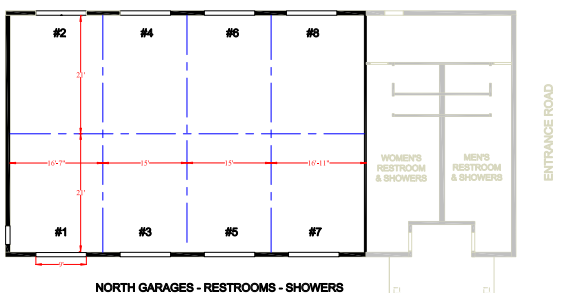

- Restrooms and Showers are located in the North Track Garage. Additional restrooms are in the timing & scoring building.



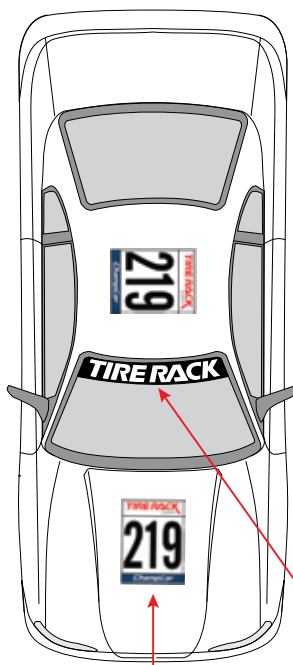

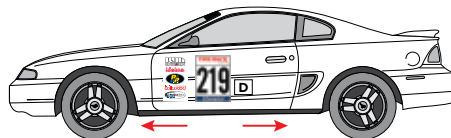
Decal Installation & Location Instructions

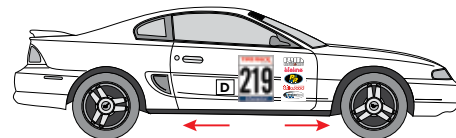


Convertibles and topless cars only. May face forward or toward drivers right like on the roof.

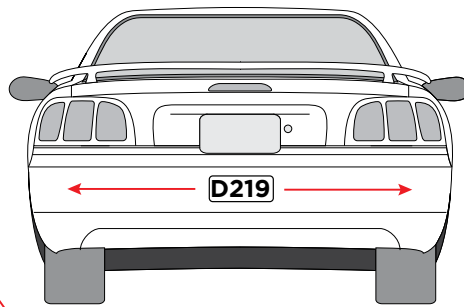
Decals MUST be installed before the car is teched for the 2020 season. You will not pass tech until the decals are installed.

Windshield banner is required at the top of the window. The background is optional. Per the BCCR, do not use white, orange, or yellow backgrounds. Cars without front windshields must have the decal at the top of the hood. The letters can be arranged to the curvature of the window.

Sponsor panel placed to the front of the number panel. Decals may be cut out from the white background, but must maintain the same vertical order and maintain a 1-inch space between the decals.

Additional event specific decals may be required at certain events. Instruction on placement of those decals will be available at the event and in the ChampCar Event Supplementals.

Event Guidelines

- The following policies are subject to change based on local government guidelines in relation to COVID-19.
- All published local guidelines will be on hand for easy reference.
- ChampCar asks that anyone who is at higher risk for severe illness, feeling unwell, or who has been in contact with anyone that is sick in the last two weeks would stay home.
- If you are healthy, but uncomfortable being around other people for fear of illness, it may be better if you skip the event. ChampCar will happily move your entry fee to another event later in the year.
- Event is closed to spectators. It is advisable that non-participating personnel do not accompany the team to the event.
- While ChampCar is not limiting the number of team members per car in attendance, each track may have restrictions that we must follow. Please read the supplemental rules for each event to see if such restrictions exist.
- ChampCar recommends all participants follow current CDC guidelines on social distancing and personal protective gear. Signs will be placed around the venue to remind people of social distancing and protective health protocols. Teams are responsible for determining which types of protective gear (mask, gloves, etc.) they choose to use and for bringing sufficient supplies for themselves.
- ChampCar will work with the track to have frequently touched surfaces such as tables, counters, doorknobs, light switches, etc. cleaned with disinfectant at regular intervals.
- ChampCar will ensure there are plenty of hand washing stations and/or hand sanitizers in and around the facility, particularly high traffic areas.
- Only essential workers are allowed in specialty work areas such as timing & scoring and race control.

Tech

- Only one team member (preferably the captain) may bring the car to tech.
- Bring your completely filled out tech form with you.
- Required decals will be available and set out on a table so you can pick up your own.
- We ask that you maintain six feet of distance from our tech inspectors.
- ChampCar will place less cars into the tech bay than normal to help maintain greater distances between people.

Gear Tech

- Arrive at gear tech fully suited up in your driver gear, carrying your helmet.
- ChampCar will hand you a gear check decal for you to apply on your own helmet.

Registration

- Only the captain is permitted to be at registration.
- If possible, complete all payments before arriving to registration.
- Registration line will be marked to maintain social distancing.
- Bring the team's completed COVID-19 waivers with you (no waiver = no driver band).
- Bring completed tech sheet and/or log book with you.
- Hard surfaces will be disinfected throughout the day.

Drivers Meeting

- Driver meetings will be held outside and comply with social distance protocols. The meetings will also be simultaneously broadcast both by FM transmitter as well as on the ChampCar YouTube Live channel. If a track does not allow public meetings of any kind, ChampCar will hold driver meetings exclusively over an FM transmitter and/or the ChampCar YouTube Live channel.
- Questions will be fielded as usual from in person participants as well as by YouTube chat.

Pit Road

- Some events may limit the number of people on pit road. Read the supplemental event rules for info. Even with no restrictions, ChampCar advises teams to not load up their pit boxes with extra people.
- Drivers will still be checked for arm bands at pit out. Please have your band ready to display to our pit out worker.
- Drivers will still need to report to Black Flag at pit in for on-track driving infractions. A ChampCar staff member will write out the infraction and place it on your windshield for you to read.
- All fueling rules remain in place.

Award Ceremony

- Award ceremony will be held outside, and social distancing protocols will be followed.

DESCRIPTION AND LOCATION OF SCHEDULED EVENT(S)

DATE RELEASE SIGNED

IN CONSIDERATION of being permitted to compete, officiate, observe, work, or participate in any way in the EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials, or permission to enter or any area to which admission by the general public is restricted or prohibited), EACH OF THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he has or will immediately upon entering any of such RESTRICTED AREAS, and will continuously thereafter, inspect the RESTRICTED AREAS which he enters, and he further agrees and warrants that, if at any time, he is in or about RESTRICTED AREAS and he feels anything to be unsafe, he will immediately advise the officials of such and if necessary will leave the RESTRICTED AREAS and/or refuse to participate further in the EVENT(S).
2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, any persons in any RESTRICTED AREA, sponsors, advertisers, owners and leasees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents, employees, representatives, owners, members, affiliates, successors and assigns all for the purposes herein referred to as "Releasees," FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.

Each of THE UNDERSIGNED, also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the State or Province in which the Event(s) is/are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
